



What's New with OneCare?

CalOptima Health offers two Medicare Advantage Special Needs Plans for seniors and people with disabilities who qualify for both Medicare and Medi-Cal.^{1,2} For the 2026 contract year, OneCare Flex Plus will be merged into OneCare Complete. There are some drug changes and new benefits as described below.

*Not all OneCare members will qualify to buy grocery items. Only members with certain chronic conditions may be eligible for extra benefits.

OneCare &more Card Supplemental Benefit

OTC drugs are not covered by Medicare Part D.³ Medi-Cal Rx may cover some OTC drugs with a prescription, but not all. OneCare members get a quarterly allowance for eligible groceries and OTC health and wellness items with no out-of-pocket costs through the OneCare &more card, without a prescription needed. Eligible groceries include, but are not limited to, fresh produce, whole foods and canned foods. Members can shop at participating stores or place OTC orders online or over the phone. Limitations apply.

Prescription Drug Coverage

Most prescription drugs are covered by Medicare Part D, but some prescription drugs or their indications are excluded from Medicare and Medi-Cal coverage, such as drugs treating erectile dysfunction (ED).³ OneCare Complete will offer enhanced coverage for treating ED, including up to six generic sildenafil tablets per month. Starting January 1, 2026, members may have a copay for brand-name drugs based on their LIS level. Members may call OneCare Customer Service to join the Medicare Prescription Payment Plan for help managing their out-of-pocket costs. Prescription Drug Mailing Service and 100-Day Supply Pharmacy Benefit

OneCare now offers a free mailing service by **SortPak Pharmacy** (Address: **655 N. Central Ave 22nd Floor, Glendale, CA 91203**; phone: **877-570-7787**; fax: **877-475-2382**; E-Scribe: **NCPDP/NABP: 0524733**). A 100-day supply of prescription drugs is also available for the cost of one month with OneCare's pharmacy benefit. Consider prescribing 100-day supplies for chronic medications and encouraging patients to enroll in mailing services to improve medication adherence.
