

Notice of Funding Opportunity: Community Enrollers for Medi-Cal — Round 2

Application Deadline — January 9, 2026 (5 p.m. PST)

Background

CalOptima Health's mission is to serve member health with excellence and dignity, respecting the value and needs of each person. With a strategic goal of decreasing health inequities, CalOptima Health is engaging in programs and expanding partnerships to better serve members who are at greater risk for poor health outcomes.

In July 2025, H.R. 1 was signed into law and enacted changes to Medicaid (known as Medi-Cal in California) enrollment that will impact Orange County residents beginning in January 2027. Some of those changes include six-month eligibility verification periods and community engagement requirements for the Medi-Cal expansion population. Additional state eligibility changes for undocumented individuals go into effect in 2026 and 2027. With these changes to the Medi-Cal enrollment process, CalOptima Health is offering this current funding opportunity to organizations and community collaboratives that support our neighbors with outreach, education and enrollment assistance.

For this Notice of Funding Opportunity (NOFO), CalOptima Health is seeking to collaborate with **single community-based organizations** or **collaborations of community partners** (further defined below) to support Medi-Cal enrollment, Medi-Cal renewals, and ongoing community outreach and education. Past efforts have led to the understanding that the most successful enrollers are those who have a community partnership approach. Organizations that can neutralize local fears, known as trusted messengers, can deliver a consistent, clear message and be drivers of successful enrollment outcomes. Organizations that understand where neighbors naturally spend their time and can frequently and consistently be present at those community sites (e.g., farmers markets, faith-based institutions, corner stores and food banks) are especially effective.

Actual Medi-Cal enrollment and renewal support is provided to individuals and families by trained enrollment entities. More information about becoming trained and the work conducted by these entities can be found here: bit.ly/3UGR6tO.

Additional support is provided by the County of Orange Social Services Agency (SSA).

Community Investment Strategy

CalOptima Health is committed to the following:

- Developing equitable systems that distribute resources among a variety of community service providers across all three service planning areas.
- Increasing the number of outreach, engagement and service providers and the capacity of these providers to add to the overall continuum of care infrastructure throughout Orange County.
- Establishing and/or using best practices in providing care by meeting members where they are and increasing access to that care.
- Delivering culturally competent services to traditionally underrepresented populations (e.g., families, seniors, LGBTQIA+ and people of color).

Funding Opportunities

CalOptima Health has committed a total of \$5 million across two rounds for this funding opportunity (Round 3 to occur in March 2026) and will fund a minimum of four applicants in Round 2 to conduct this work.

Applicants may apply as a <u>single organization</u> or as a <u>collaborative</u>. To qualify as a collaborative, there must be a lead applicant organization and partner organizations from at least two other sectors (e.g. nonprofit/community-based organizations/social service; health care providers such as hospitals, community clinics and medical groups; school/educational entities; city/county government; business community; faith-based institutions; family resource centers; or food purveyors [farmers markets, corner stores, grocers, food banks]).

Grant requests must be for a **24-month period** and within the range of \$200,000 (minimum) to \$500,000 (maximum request) for an individual applicant or up to \$625,000 (maximum) for a collaborative application. The proposal and objectives must be commensurate with the funding level requested.

This funding opportunity is designed to engage both organizations with a history of conducting community enrollment support and those who are newer to the space but with a strong connection to their community and effective outreach and engagement strategies.

To facilitate the submission of competitive proposals, CalOptima Health will open a grant application portal for eligible applicant organizations from December 1, 2025, at 9 a.m. until January 9, 2026, at 5 p.m. PST. The link to that portal is: https://webportalapp.com/sp/communityenrollers2.

Requirements for Community Enrollers Grants

Measurable Outreach and Engagement Objectives

Single organizations and collaboratives applying for these funds are required to provide a program implementation plan that outlines how they will use grant funds to engage the target populations and meet the minimum service thresholds provided below.

Applicants must average, at a minimum, the following metrics across a 24-month period:

- 1. Be physically present in the community at least **four times per month** at existing gatherings and events already being hosted within the community. CalOptima Health encourages being available in places where community members naturally gather, as opposed to designing and hosting new, large promotional events. These could be events occurring at collaborative partners' locations (e.g., faith-based weekly services, farmers markets, mobile clinic pop-up sites) and excluding where enrollment services are already being provided.
- 2. Complete a minimum of **25 Medi-Cal applications and renewals (combined) per month**. Enhanced Care Management (ECM) providers who apply for and receive these funds cannot include any ECM recipients who are reenrolled during this grant period, as this service is already billable as an ECM provider.
- 3. Provide face-to-face enrollment and renewal education and/or outreach to 1,000 unduplicated individuals on an annual basis (approximately 84 individuals per month).

If applicants need time for planning and ramp-up, they must still **average** the above metrics across the full 24-month period.

Regional Approach

This funding opportunity embraces a place-based approach to community enrollment work. Applicants must be able to fully describe the specific regions or communities of Orange County in which they are proposing to work. Applicants must genuinely describe the cultural influences, trusted institutions/influencers, common modes of communication and neighborhoods within that region and how their experience, strategies and partnerships are well matched to those regions and will produce the intended results.

CalOptima Health will support grantees by sharing information with community enrollers on Medi-Cal members who are due for renewal and are at risk of losing their coverage. Awarded applicants must be prepared to sign a Business Associate Agreement for Health Insurance Portability and Accountability Act (HIPAA) compliance.

Grant Budgets, Amounts, Duration and Allowable Expenses

CalOptima Health has committed a total of \$5 million across two rounds for this funding opportunity (Round 3 to occur in March 2026) and will fund a minimum of four applicants in Round 2 to conduct this work.

Grant requests must be for a **24-month period** and must be within the range of \$200,000 (minimum) to \$500,000 (maximum request) for an individual applicant or up to \$625,000 (maximum) for a collaborative application. Proposed budgets should adequately reflect the scope and depth of program objectives/deliverables.

Allowable Expenses

Examples of allowable expenses for grant funds include hiring and onboarding staff, technology purchases, and the creation and distribution of additional educational outreach materials (toolkits in CalOptima Health's threshold languages will be provided to all grantees).

Unallowable Expenses

Grant funds cannot be used to pay for lobbying activities or staff time that is already funded through claims payments for the provision of other Medi-Cal services.

Entities Eligible to Apply

This funding opportunity is designed to support applicants who meet the following criteria:

- 1. Single applicants or the lead applicant of a collaborative must **not** have an existing, active grant with CalOptima Health that supports community enrollment work.
- 2. Single applicants or the lead applicant of a collaborative must be a 501(c)(3) or equivalent in good standing with the IRS. Equivalent organizations include tribes, public schools, universities, and local, state, or federal government agencies and programs. Organizations that do not meet this criterion may still apply as a part of a collaborative, but not as the lead entity.
- 3. Single applicants or the lead applicant of a collaborative must employ or have a plan to employ trained community enrollers.
- 4. Any grantee who will be doing the actual enrollment work must sign a Business Associate Agreement to be in HIPAA compliance to receive data from CalOptima Health.
- 5. Applicants who previously received funding from CalOptima Health must be/have been in good standing with the terms of that grant agreement to be eligible for new funding.
- 6. Organizations may only submit one proposal for this Round 2 funding opportunity.

Proposal Evaluation Criteria

Criterion	Points	Description
CalOptima Health Value Alignment	5	Program is trauma-informed, inclusive, person-centered and reflects a commitment to health equity.
Program Description	10	Program description is clear, concise and reflects best practices that support the approach taken.
Community Connectedness	15	Description of the communities is thorough, including cultural influences and trusted sources, and there are documented partnerships in the neighborhoods.
Program Implementation	15	Plan is complete and includes specific objectives, logical and feasible activities, as well as clearly defined measures of success.
Sustainability	5	Program or projects is sustainable beyond this funding opportunity if funding is awarded, or is time-bound and does not require continuous funding.
Readiness	10	Program that can launch soon after the grant award will receive more points.
Experience	15	Expertise in providing proposed services and/or implementation of similar projects in the past. Must be clearly articulated in the application.
Capacity of Applicant	15	Able to demonstrate financial and management capacity to carry out the project, as evidenced in the submission of required materials in the application portal.
Evaluation Plan	10	Applicant clearly articulates a feasible and well-thought-out plan for evaluating project success.

Future Round 3 NOFO

CalOptima Health will launch the Community Enrollers Round 3 NOFO on March 2, 2026, which will mirror Round 2 with the same requirements and distinctions. To be eligible, lead applicants must **not** have active community enrollers grant in progress (as either a single applicant grantee or a collaborative member). Organizations that are not successful in Round 2 may apply again.
