CalOptima Health OneCare Flex Plus 的雜貨福利是針對慢性病患者的特殊補充計劃的一部分。並非所有會員都符合資格。要使用雜貨福利,CalOptima Health OneCare Flex Plus 會員必須有一種或多種併發症和醫療上複雜的慢性病,且危及生命或嚴重限制投保人的整體健康或功能。符合條件的疾病包括但不限於心血管疾病、糖尿病、慢性心力衰竭、慢性肺病或末期腎臟病。即使會員有慢性病,會員也不一定會獲得雜貨福利。獲得雜貨福利取決於會員是否有住院的高風險或其他不良健康結果,以及是否需要重症的照護協調。
