Notice of Funding Opportunity

Application Deadline — January 31, 2023 (11:59 p.m. PST)

Background

CalOptima Health's mission is to serve member health with excellence and dignity, respecting the value and needs of each person. With a strategic goal of decreasing health inequities, CalOptima Health is engaging in programs and expanding partnerships to better serve members who are at greater risk for poor health outcomes, especially those experiencing homelessness.

As one tactic in a larger strategy, CalOptima Health is participating in the Department of Health Care Services' Housing and Homelessness Incentive Program (HHIP), a voluntary incentive program intended to support the delivery and coordination of health and housing services for Medi-Cal members who are experiencing homelessness or are at-risk of homelessness by 1) rewarding Managed Care Plans (MCPs) for developing the necessary capacity and partnerships to connect their members to needed housing services; and 2) incentivizing MCPs to take an active role in reducing and preventing homelessness.

Through this program, CalOptima Health *can earn up to* \$83 million in funding for meeting specific program measures that fall under three priority areas: 1) infrastructure to coordinate and meet member housing needs; 2) partnerships and capacity to support referrals for services; and 3) delivery of services and member engagement. The program runs from January 2022 through December 2023.

Four HHIP metrics are driving CalOptima Health's investments, and the agency must demonstrate progress on the metrics to DHCS in order to obtain future incentive dollars:

- 1. Number of members receiving Enhanced Care Management and/or Community Supports
- 2. Number of members who are screened for homelessness
- 3. Number of members who are successfully housed
- 4. Number of members who remain successfully housed

To address these metrics, increase the uptake of new benefits and implement the investment plan created in partnership with the Orange County Continuum of Care, CalOptima Health has designed the following community investment strategy and related funding priorities, which will be **open for applications January 23–31, 2023**.

Community Investment Strategy

CalOptima Health is prioritizing projects and programs that are trauma-informed, inclusive, nonresidency restricted, low barrier, and aligned with housing-first and harm-reduction principles. This includes ensuring the "voice of lived experience" is integrated into all phases: design, development, implementation and evaluation.

CalOptima Health is committed to the following:

- ▶ Working toward a cohesive, countywide approach to address and prevent homelessness.
- Developing equitable systems that distribute resources among a variety of community service providers across all three Service Planning Areas.
- Promoting and facilitating innovation in data collection and sharing, with emphasis on greater integration across systems.
- Increasing the number of service providers and the capacity of these providers to add to the overall continuum of care infrastructure throughout Orange County.
- Establishing and/or using best practices in providing care by meeting members "where they are" and increasing access to that care.
- Delivering culturally competent services to traditionally underrepresented populations (e.g., families, seniors, LGBTQIA+ and BIPOC).
- Investing in and implementing programs that add to the current available affordable housing pool.

Description of Funding Priorities

All applications must demonstrate how the request increases the number of people connecting to permanent housing or an increase in permanent housing units.

This funding opportunity is purposefully broad in order to solicit as many ideas from organizations throughout Orange County working to address the homelessness crisis. Creativity in bridging people experiencing homelessness into permanent housing and bringing online new permanent housing units is encouraged. The primary objectives of these funding priorities are to ensure all individuals experiencing homelessness have access to housing and supportive services that center their lived experience, are reflective of their unique experiences, and are culturally appropriate.

Priority #1: Equity Grants

CalOptima Health is interested in identifying and supporting organizations providing residence, housing navigation, placement or tenancy sustaining/supporting services to these specific populations of focus:

- Transitions Aged Youth (TAY)
- Families with children (under 18)
- Older adults (age 55+)
- LGBTQIA+ populations
- Justice-involved individuals

Organizations with annual operating budgets of \$5 million or less are encouraged to seek funding through this opportunity to: 1) increase capacity to provide supportive services that connect individuals to permanent housing; 2) improve, update or make more accessible permanent housing units to better serve a population of focus; or 3) bring online new permanent housing units that are dedicated to the population of focus.

Priority #2: Capacity Building and Infrastructure Grants

CalOptima Health is interested in identifying and supporting organizations providing housing navigation, landlord relationship building and other services that connect individuals experiencing homelessness to permanent housing. Projects and services do not have required activities other than to demonstrate an increase in the number of individuals getting connected to permanent housing.

CalOptima Health is also interested in supporting access to permanent housing for current voucher holders not yet connected to a unit, so projects that address this issue are encouraged. Finally, projects that highlight equitable and countywide access will be prioritized.

Priority #3: Capital Grants

CalOptima Health is interested in supporting the development, renovation, expansion, furnishing and opening of permanent housing units. Projects that highlight equitable and countywide access will be prioritized.

Permanent supportive housing merges affordable housing assistance with services to aid individuals experiencing homelessness. These units can take a variety of forms, from shared living spaces to standalone units. Residents are usually offered supportive services that help them successfully remain housed, such as opportunities for community socialization and connections to social services and public benefits, among other things. Supportive services for these types of funded projects do not necessarily need to be provided by the applicant organization itself.

Grant Budgets, Amounts and Duration

Grant requests must be at least \$50,000 and cannot exceed the total amount available for each funding priority (see below). However, CalOptima Health will be working to award funds across all three Service Planning Areas in each of the funding priorities. For awarded grants, an initial payment is made upon receipt of the grant agreement. Subsequent payments are issued upon successful completion of agreed-upon deliverables. Funds may be used to enhance or expand staffing and services within existing programs, create new programming, or replace funding that is ending.

*Prohibited budget items include lobbying and ongoing rental assistance.

Entities Eligible to Apply

- 1. Applicants must be a 501(c)(3) or equivalent in good standing with the IRS. Equivalent organizations may include tribes, public schools, universities, and local, state or federal government agencies and programs.
- 2. Applicants must have operations in Orange County and currently serve CalOptima Health members through their programs and services.
- 3. Equity grant applicants must have annual operating budgets less than or equal to \$5 million.
- 4. Applicants may submit only one application per funding priority (no more than three total).
- 5. Applicants must propose projects or programs that align with one or more of the funding priorities and present a plan that aligns with connecting individuals to permanent housing or increasing the number of permanent housing units available in Orange County.
- 6. Applicants that previously received funding from CalOptima Health must be/have been in good standing with the terms of that grant agreement to be eligible for new funding.
- 7. Funds must benefit actively enrolled CalOptima Health members.
- 8. Applicants are strongly encouraged to apply for funds when they are ready to implement the activity proposed for funding.
- 9. There are no requirements for cost sharing, matching or cost participation.
- 10. **Remember:** Carefully review all threshold eligibility requirements. Applicants who fail to meet threshold requirements will be deemed ineligible. Applicants must successfully complete an application and submit it by the deadline to be considered for funding.
